

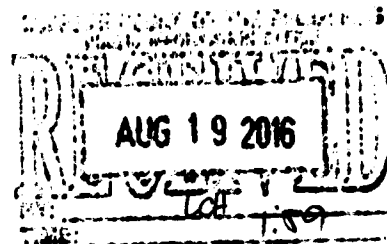

WHEREAS, G.R. No. 225973 is scheduled for preliminary conference and oral arguments on August 22, 2016 and August 24, 2016, respectively;



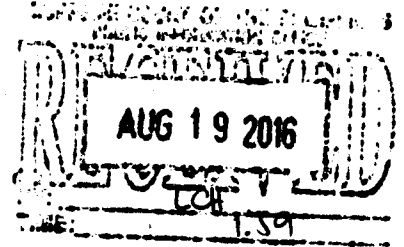


